AMENDMENT NO. 1 TO USE PERMIT AGREEMENT FOR PUBLIC PROPERTY (STREETS) BY AND BETWEEN CITY OF BETHLEHEM AND ARTSQUEST

AMENDMENT made this _____ day of ______, 2015, by and between the CITY OF BETHLEHEM, Pennsylvania, hereinafter referred to as the "City" and ARTSQUEST, hereinafter referred to as "Permittee".

WHEREAS, the parties entered into a Use Permit Agreement for Streets dated May 7, 2014, pursuant to which the City granted a Use Permit to the Permittee for the premises described, for the purposes described and for the duration described therein; and

WHEREAS, the parties agree to amend the Use Permit Agreement on the following terms and conditions.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto, intending to be legally bound hereby, covenant and agree as follows:

- 1. The Duration of the Use Permit Agreement for Streets for 2015 is hereby amended to read as follows:
 - a.) Main Street between Lehigh Street and Spring Street Only
 - from 8:00 a.m. Monday, August 3, 2015 until 5:00 p.m. Wednesday, August 19, 2015.
 - b.) First Street between Founders Way and Polk Street, allowing for access to Steel Ice Center and its parking lot
 - from 8:00 a.m. Sunday, August 2, 2015 until 5:00 p.m.
 Wednesday, August 19, 2015.
 - c.) All Other Premises North Side
 - from August 7 to August 16, 2015 only between the hours of 8:00 a.m. and 11:30 p.m. each day.
 - d.) All Other Premises South Side
 - from August 6 to August 16, 2015 only between the hours of 8:00 a.m. and 11:30 p.m. each day.

2. All other terms and conditions contained in the original Use Permit Agreement for Streets shall remain in full force and effect.
