BETHLEHEM CITY COUNCIL MEETING 10 East Church Street – Town Hall Bethlehem, Pennsylvania Tuesday, June 16, 2015 – 7:00 PM

INVOCATION

Father Anthony P. Mongiello, Pastor of St. Anne's Church, offered the invocation which was followed by the pledge to the flag.

PLEDGE TO THE FLAG

1. ROLL CALL

President Reynolds called the meeting to order. Present were Bryan G. Callahan, Eric R. Evans, Michael D. Recchiuti, Cathy Reuscher, Louis N. Stellato, Adam Waldron, and J. William Reynolds, 7.

2. APPROVAL OF MINUTES

The Minutes of June 2, 2015 were approved.

3. PUBLIC COMMENT

Impervious Coverage

Albert Bernotas, 1004 Johnston Drive, remarked he hopes the vote tonight is 7-0 in favor of the Impervious Coverage. He inquired if anyone on Council was following up on donation drop boxes and the pods that we see in the City. He knows that Mr. Evans raised some concern about that.

President Reynolds noted that would be a topic for the second courtesy of the floor.

Mayor's Administrative Order

Stephen Antalics, 737 Ridge Street, queried if Council would entertain any comments on the Mayor's Administrative orders since they will be voting on them tonight.

President Reynolds replied yes.

Mr. Antalics mentioned the Administrative Order reappointing Beth Starbuck to the Historic Conservation Commission – South Bethlehem and Mount Airy and stated he takes strong exception to this reappointment. Mr. Antalics feels her behavior concerning the project on Fourth Street was not in the best interest of the people of the South Side. He referenced Ms. Starbuck's opinion that the project was inappropriate but justified it on the basis of the building of Hotel Bethlehem in 1922. Mr. Antalics noted that Certificates of Appropriateness were not required when the hotel was built. He stated historic preservation did not enter in her rationale; rather there was an economic concern. He feels this was a violation of the Commission. For those reasons he feels this individual does not qualify to continue on the Commission.

The Application Renewal Fee of \$400 has been paid, and the Renewal Application meets the requirements that include, but are not limited to, right of way permit, insurance, health, business privilege, etc. There appears to be no changes from the previous application.

B. Director of Water and Sewer – Recommendation for Award – Pennoni Associates

The Clerk read a memorandum from Edward Boscola, Director of Water and Sewer recommending a contract with Pennoni Associates Consulting Engineers, for the design, permitting, and construction of the 16" diameter water main and associated appurtenances along Rte. 512 between Jaindl Boulevard in Hanover Township and Silver Crest Road in East Allen Township. The term of the contract is from the Notice to Proceed to December 31, 2017. The fee for the contract is \$159,900.

President Reynolds stated Resolution 9 E is on the agenda.

C. Police Chief – Special Event Parking Fines - Musikfest

The Clerk read a memorandum dated June 9, 2015 from Mark DiLuzio, Chief of Police, requesting consideration of a proposed Resolution and boundary map approving increased parking fines for Special Event Parking during Musikfest 2015. The time period covered will be from 12:00 PM on Friday, August 7, and last through 11:59 PM on Sunday, August 16, 2015. The Special Events Parking Districts will need to remain the same as last year, including the extension into the South Side.

Mayor Donchez informed they will be advertising the Citizens Academy on our web page this week or the following week. It is anticipated that the program will run from September through October.

Mr. Stellato and Mr. Evans sponsored Resolution No. 2015-145 that granted approval of a Sidewalk Vendor Renewal Application for a sidewalk vendor cart for Christopher Morales, Easy Weenies, at 15 West Fourth Street, for the hours of 10:00AM – 6:00PM, 12:00AM – 4:00AM, Monday/Tuesday through Saturday/Sunday, for the renewal period March 20, 2015 to March 20, 2016.

Mr. Recchiuti queried if Mr. Morales has been operating for three months without a permit because this is backdated to March 20th.

Michael Alkhal, Director of Public Works does not believe he is but not certain at this time. He remarked he has not sent an inspector to check if he is out there or not, so he cannot say whether he has been or not operating the vendor cart.

Mr. Recchiuti noted this is the second or third year in a row that a renewal for this has been well after the permit expired. He queried whether this is the fault of Mr. Morales or the City.

Mr. Alkhal noted Mr. Morales has to come in for this permit and we did remind him. He continued, it does take a while for him to get in to renew his permit. The process includes the fact that he does have to get various approvals and the timing did not line up perfectly this year. Mr. Alkhal added that we are still struggling trying to get all the approvals in the same timeframe and we finally have done that now.

Mr. Evans remarked he does have the same concerns as to whether this is a process or a vendor issue. He noted if it is related to the process maybe we can help if there are any changes we can make. We only have one street vendor. It does seem to be that this is always a few months late. If it is a

vendor issue then maybe someone from the Department could speak with him so this does not become a habit where he is not following the rules that we have set. Mr. Evans stated this is just the concern he has regarding this matter.

Mr. Alkhal reported they have discussed this with the vendor repeatedly each year.

11. PUBLIC COMMENT.

Impervious Coverage, Zoning/Law/Code Enforcement, Streaming of Meetings

Albert Bernotas, 1004 Johnston Drive, stated he would like to thank Mr. Recchiuti for catching the 50% on the impervious coverage and added we will miss having a lawyer on Council. Mr. Bernotas stated he was hoping that the donation drop boxes and pods were not forgotten about. He believes in the past Mr. Evans has asked Planning to take a look at that issue. He was not certain if it would be appropriate at this moment to respond to this matter.

President Reynolds stated Mr. Bernotas should ask Planning after the meeting. This is something Council has reached out to the Administration about before but he does think that someone from the Administration would be able to tell him after the meeting.

Mr. Bernotas noted there are a few things he would like to see in the City. He would like to emphasize zoning enforcement, law enforcement and code enforcement. He believes that everyone has probably already heard the terminology of the broken windows concept in that you need to fix the small problems to make sure the big problems do not become an issue. Mr. Bernotas mentioned he had heard there were to be Police Officers on the south side on bicycles. He thinks that is a terrific measure so they are in a place where crime is taking place and enabling them to quickly respond. Mr. Bernotas noted that the Police Department publishes a crime report everyday which he does read just about every day, even if he is out of town because it is on the web. There are a few things the City does not publish which he would like to see. He would like to see zoning enforcement publish what zoning complaints occurred and how they were resolved. He continued he would also like to see code

enforcement published, hopefully on a daily basis, the code violations that occurred and how they were resolved. Mr. Bernotas mentioned permit publishing is occurring now but it is occurring 15-20 days after the close of the month. He added, you cannot appeal a permit after 30 days, although he is not sure of the law. Mr. Bernotas spoke about streaming of these meetings which came up years ago. Mr. Bernotas hopes that Council would take a look at maybe some potential for streaming Council meetings, zoning meetings and other meetings without it costing too much. There are times when he cannot make these meetings and he would love to be able to stream these meetings or maybe look at a tape.

Public Comment/Five Minute Rule

Stephen Antalics, 737 Ridge Street, stated he wanted to continue his campaign to bring back interaction between Council and the citizens. Mr. Antalics feels the five minutes rule for the public comment and lack of comments by Council is disrespectful. He referenced a non-profit owing the City funds and receiving free utilities while having events, and violating the use of City property. He continued this went to a Grand Jury, reflecting that the citizens were raising the issue and should have received answers. He added, a conclusion could be that Council does not care or it was following its policy of no comments if an issue is sensitive, and since the person involved with the non-profit was a member of Council, perhaps Council was protecting one of their own.

Mr. Antalics remarked it seems that citizens are important every four years, when they receive phone calls and mailers during the election campaign. Mr. Antalics noted after the candidates are elected, they then become a member of the club. Mr. Antalics thinks that Council needs to review their policies; eliminate the five minute public comment rule and use the gavel for control. He feels each Member of Council should be independent of the other six members and act accordingly based upon the needs of the citizens and comments they might make. Mr. Antalics noted that not interacting with the citizens is not democratic and a violation of public meetings. Mr. Antalics advises those running for Council to pay attention to this and do not fall into that trap. Mr. Antalics then asked if he could have 15 more seconds.

President Reynolds stated no and that we have a five minute time limit. He added all Council Members are available after the meeting.

Mr. Antalics stated President Reynolds just proved his point.

President Reynolds reiterated we are all available after the meeting if he would like to come up to have a conversation with us.

The meeting was adjourned at 7:40 p.m.
