## Dear Members of Council:

Attached please find the final budget and program list for the 2016 CDBG/HOME awards. HUD released the official allocations to each grantee last week, and we were pleased to find that Bethlehem is receiving \$1,276,895 in CDBG funds and \$352,832 in HOME funds. When I presented the anticipated budget back in the fall, I had used the historically accurate 10% reduction per year to make an educated guess at the 2016 award amounts. In reality, Bethlehem wound up with \$233,950 additional in CDBG funds and \$42,832 additional HOME funds over what was included in the presented budget.

Because of this unexpected increase in funding, we have modified the budget to award slightly higher amounts to certain applicants. Additionally, we have awarded \$147,850 to the Redevelopment Authority to fund a blight elimination program. As we become more aggressive in blighting properties, we find there is no incentive for property owners to relinquish the property when we have no funds to offer. Using a small portion of our CDBG award to acquire these blighted structures allows the City to prevent further deterioration in these neighborhoods.

The updated budget is scheduled to be presented to the Finance Committee on March 9th. The Community Development Committee will review the inclusion of the new blight program on March 15<sup>th</sup>, immediately prior to the full Council Meeting.
