Description of project or scope of services to be provided:

The consultant is to provide construction inspection services over the course of construction of the replacement of the High Street Bridge Project as required by the PA Department of Transportation. The consultant will utilize the Penn DOT ECMS and CDS NextGEN systems for managing the project. The consultant will review all pay applications being made by the contractor and verify that all work is in compliance with specifications prior to approval of payments.

• State the actual or estimated price to the City or the proposed Department budget allowance for the initial term; and state payment rate per unit of service if applicable:

Pending a detailed price proposal from TPD which has to be in conformance with hours and rates dictated by Penn DOT and is expected to be approximately \$128,000. This request is being made in this manner and prior to receiving the actual price proposal in order to avoid further delays on this project.

• Reasons for recommendation of Administration and Council approval of contract:

In accordance with Penn DOT Procedures, Statements of Interest (SOI) for Construction Inspection services were solicited from four firms on 12/07/15. SOI were received from two of the firms. We reviewed and evaluated the SOI and ranked the firms based on the criteria set forth in the advertisement. Based on the ranking it was determined that T&M Associates was the most responsive firm with the necessary experience and staffing to perform the tasks required.

However, T&M Associates' field office overhead rates were not approved by Penn DOT. Therefore, in order to meet necessary deadlines for this project, we are recommending that the contract be awarded to the second ranked firm of Traffic Planning and Design, Inc.

Please approve this recommendation by passing the accompanying resolution. A vote of final approval is requested at the first City Council agenda listing of this matter.
