Due to further measurements and prior meeting with South Bethlehem Historic Conservation Commission, we would like to amend prior request and need to add following details:

- 1- sign extended to 14' wide
- height of first letter "C" reduced to 32", hopefully, accommodating Board's request in their concern of second landing's sill obstruction




